### **President's Corner**

Included among our recently deceased classmates was **Ted Parsons (18)**, with whom I had a brief, but unforgettable, encounter in the 1970s. Its genesis was an article I read in Time Magazine. about a Navy Lieutenant, who was suing the Navy because he broke his back during Survival, Evasion, Resistance, and Escape (SERE) training.

I was working in the Navy Secretariat at the time and felt a need to get out front of the Congress on the matter by taking a hard look at the training to ensure there was no physical abuse taking place. For those unfamiliar with this particular training, it is designed to provide a realistic prisoner of war experience for Navy pilots, and anyone else who might conceivably get captured behind enemy lines.

A few weeks later as I made my way to the training facility in the California desert, I was surprised to find Ted in charge. Although I hadn't known him at the Academy, he was clearly a great guy; and we quickly became good friends. With this instant rapport, he showed me the full gamut of what was taking place.

Basically, the process begins by setting the participants free in the California desert to test their survival skills and ability to evade capture. Because there's really no place to hide, all of them are quickly captured; and the ordeal begins. The first thing I witnessed was the waterboarding of one of those captives, and it went downhill from there.

After several days of this, the training concluded with the playing of the Star-Spangled Banner over the loudspeakers surrounding the compound. At that point, the prisoners exited their cages and stood at attention, many with tears streaming down their faces. To a man (and there were only men receiving such training in those days), they were glad to have had the experience but absolutely didn't ever want to do it again. As for abuse, I had never in my life seen so much of it. However, in the cold light of day, it seemed more than worth any anguish it might cause. And Ted did a great job of overseeing it all for close to four years.

Later, I visited an air base outside of Spokane, Washington where the Air Force provided its version of the same training. It was a good bit milder; and from what I later came to understand, Air Force POWs had a tougher time adjusting in captivity. Doug

name. The first shell was dedicated 28-29 years ago. Skip was a Company Officer at the academy from 1969 to 1972. Additionally, during this period he was also the head lightweight crew coach where he mentored and guided countless midshipman to become hardworking oarsman, dedicated officers, and men of character. In the years that Skip coached the Navy Lightweights, the team earned three medals at the Eastern Sprints - a Silver and two Bronze. However, their standout performance during Skip's tenure was winning the 1971 Head of the Charles race (Charles River, Boston, MA) and breaking the course record for the Lightweight Eight Division. Members of the Sweetser family were present for the dedication - wife (Nancy), daughter (Janice), sons (Wes and Seth) and seven grandchildren. All the grandchildren participated in the traditional christening ceremony of pouring water over the prow of the shell.
